**Important Note:**

1. The horizontal reservation to Divyangian (Specially Abled Persons) candidates shall be provided as per Government of Rajasthan rules as amended from time to time that means the candidate shall be included/adjusted in same category to which he/she belongs.
2. In case of unavailability of eligible and suitable candidate of Rajasthan from BC/MBC/EWS category, these posts shall be filled as per Govt. of Rajasthan rules.
3. Reservations to female candidates, including widows and divorcees, shall be provided as per the Rajasthan Teachers and Officers (Selection for the appointment) Act, 1974, for bonafide residents of Rajasthan vide Government of Rajasthan order No. 3(49) Krishi/Group—3/2016 dated 17.3.2017 and as amended from time to time as per the reservation policy of the Government of Rajasthan.
4. In case of unavailability of eligible and suitable divorcee or widow candidates, these posts shall be filled through interchange among divorcee/widows of the same category, and if eligible and suitable divorcee/widow



candidates are not available, these posts shall be filled through other women candidate of the same category. Further, in case of unavailability of eligible and suitable women candidates, these posts shall be filled through male candidates of the same category such as reserved.

5. The widow candidate will have to furnish a certificate of death of her husband and a link certificate with her husband (ration card, Voter ID, etc.) from the competent authority, and in the case of the divorcee, she will have to furnish the proof of divorcee issued by Hon'ble Court along with application form.
6. Reservation shall be provided to SC/ST/BC/MBC/EWS candidates as per the Rajasthan Teachers and Officers (Selection for the appointment) Act, 1974, as amended from time to time and as per the reservation policy of the Government of Rajasthan for bonafide residents of Rajasthan only. Candidates must submit their relevant certificate along with the application form.
7. The candidates belonging to BC/MBC/EWS must submit their caste certificate issued on the basis of the income of mother/father by a competent authority recently (Not before twelve months from the last date of application submission and date of interview also, if called) for the purpose of non-creamy layer. The candidates applying under EWS category should attach EWS Income & Assets Certificate issued recently by competent authority in the standard format.
8. If eligible and suitable candidates are unavailable for any reserved post shown for the Scheduled Castes and Scheduled Tribes of Rajasthan, these posts will not be filled by General Category candidates.
9. Candidates belonging to SC/ST/BC/MBC/EWS of states other than Rajasthan will be considered in the General category.



A minimum of 55% marks (or an equivalent grade in a point scale wherever a grading system is followed) will be required at the Master's level degree in the relevant subject from the recognized University. A relaxation of 5% will be provided (from 55% to 50%) in the marks, at the Master's level for SC/ST category candidates.
- ii. One publication in NAAS rated referred journal.
- iii. Candidate must have cleared the National Eligibility Test (NET) for Assistant Professor(s) and equivalent position, conducted by ASRB/U.G.C./C.S.I.R. or similar test accredited by the UGC like SLET/SET.
- iv. Essentiality of NET can be waived off for the candidates holding Ph.D. degree provided it has been done with course work as prescribed by the UGC Regulations, 2009 or 2016 and as amended by the ICAR/UGC from time to time [and also as per ICAR letter No. 23(46)/2010-EQR (Edn.) dated 26th December, 2011, issued by ADG (EQR) and the candidate has at least two full length publications having a NAAS rating not less than 4 on the last date of submission of application.

Bachelor's and Master's degree in relevant branch of Engineering/Technology with first class or equivalent either in Bachelor's or Master's degree but at least 55% marks (or an equivalent grade in a point scale wherever a grading system is followed) will be required at the Master's level degree in the relevant subject from the recognized University if first class in Bachelor's degree. A relaxation of 5% will be provided (from 55% to 50%) in the marks, at the Master's level for SC/ST category candidates.
- ii. One publication in NAAS rated referred journal.



Master degree with 55% marks (or an equivalent grade in a point-scale wherever the grading system is followed) in the concerned subject from an Indian university, or an equivalent degree from an accredited foreign university as per the details given below. A relaxation of 5% will be provided (from 55% to 50%) in the marks, at the Master's level for SC/ST category candidates.


- i. A relaxation of 5% will be provided (from 55% to 50%) in the marks, at the Master's level for SC/ST category candidates.
- ii. 



  - i) Who has been convicted by any Court of Law or any criminal proceedings are pending against him;
  - ii) Who is not a citizen of India; and
  - iii) Any other category of person disqualified for appointment by the Government of Rajasthan/ RPSC from time to time.
29. The candidates are advised to carefully go through the details of Score Card and the "Information for the candidates" relevant to the post applied for.
30. The application form should be filled up carefully as it is considered for evaluation and scoring.
31. The Screening Committee will go through the application for evaluation and award of scores. Hence, the candidates are instructed to fill them legibly or even type on separate sheets.
32. Providing any false information or claim may render the candidate liable to action as deemed fit by the University including disqualification of candidature

#### **B. SPECIAL INSTRUCTIONS/CLARIFICATIONS**

1. The direct recruitment to the posts of Assistant Professor, Assistant Librarians and Superintendent Physical Education in the University shall be on the basis of merit wide advertisement and selections by the duly constituted Selection Committees.
2. The University will adopt short-listing criteria to restrict the number of candidates to be called for interview to a reasonable number by criteria as Screening Committee decide.
3. **The candidates from Non-Government organizations are required to submit form-16 for claiming their monthly emoluments in support of their claimed experience.**
4. All appointments made shall be provisional and subject to verification of certificates through proper channels. The University shall verify the documents and antecedents of the applicant at the time of appointment or anytime during the tenure of the service. In case it is found at any point of time that any documents / information submitted by the candidate is false or the candidate has suppressed any relevant information, the services of the selected candidate shall be terminated forthwith without assigning any further reasons and



5. Any type of corrigendum/addendum/amendments/notice/updation etc. related to this advertisement shall be uploaded on university websites [www.sknau.ac.in](http://www.sknau.ac.in) only. Further, the university will not send any further information/call letters by post/newspapers. SKNAU will not be responsible for invalid/wrong e-mail ID and Mobile No. mentioned by the candidates. 6. Mere fulfilling eligibility conditions will not entitle any candidate to be called for interview. Stringent criteria will be applied for shortlisting the candidates. The University reserves the right to place reasonable limit on the total number of candidates to be called for interview.
7. Candidates who have been awarded Ph.D. from foreign Universities should enclose "Equivalence Certificate", issued by the Association of Indian Universities, New Delhi, without which their candidature will not be considered and application will be rejected. However, the persons who have acquired Ph.D. degree from Foreign University through nomination by MHRD's foreign scholarship programme will be exempted from the Equivalency Certificate.
8. All the qualifications and experience will be counted up to the last date of applications. Any additional qualification and experience acquired after the closing date will not be taken into account at the time of screening/selection.
9. The University reserves the right to withdraw any advertised post at any time without assigning any reason. The right is also reserved with the university either to fill or not to fill the post and the decision of the university in this regard will be final.



21. The age of the superannuation for all the posts is as per norms of University/ Govt. of Rajasthan rules.
22. Candidates shall have to produce original documents at the time of appearing in interview/skill test/document verification. The credentials of the candidate viz. self name/parents name etc. must be uniform across all marksheet/degree certificates/category certificate. In case, originals are not produced by the candidate the candidate or mismatch identified in credentials identified at any stage, the candidate will be not be allowed for skill test/interview etc.
23. After the interview in case of selections the appointment will be provisional and is subject to the community certificate being verified through the proper channels. 
